Planning Board, Planning Commissioner and Board of Appeals Members Education Course

This FREE course, required as part of the Smart and Sustainable Growth Act of 2009 passed by the Maryland General Assembly, required Planning Commission, Planning Board, and Board of Appeals members to complete an education course on or before July 1, 2010. For new members, the course is required to be completed within 6 months after appointment to the Commission or Board. The Maryland Department of Planning (MDP) and the Maryland Planning Commissioners Association (MPCA) are offering this course to those who still need to take it.

The Course covers topics such as foundations of planning, the role of the comprehensive plan, standards for special exceptions and variances and implementing ordinances such as zoning and subdivision and adequate public facilities, planning law, ethics and the latest legislative and policy developments concerning planning in Maryland.

Leveraging Private Investment to Capitalize Energy Improvements

Savvy leaders across the country are learning how to leverage private sector investments to "green" facilities and save on energy costs. Find out how your county can successfully use "green bank" lending programs and take advantage of public private partnerships to retain local debt capacity. Speakers will discuss Power Purchase Agreements and showcase model projects that use Commercial Property Assessed Clean Energy lending. Innovative approaches for school renovations and waste-to-energy solutions also will be presented.

The Chesapeake Bay Watershed Agreement – Updating Strategies for Our Biggest Natural Asset

The 2014 Chesapeake Bay Watershed Agreement consolidated commitments from six states and the District of Columbia to develop and follow management strategies for Bay cleanup goals. The voluntary agreement puts Maryland and our neighboring

jurisdictions on a path toward Bay cleanup, alongside the other driving forces, notably the EPA's "Total Maximum Daily Load" mandate and stormwater requirements. This session will focus on the progress so far in developing and implementing these strategies, the roles for county officials and county governments in keeping Maryland on track, and decisions awaiting policymakers here and across the Bay watershed.

Is Your County Struggling with a Policy Challenge? Get Some PALS to Help!

The University of Maryland has created an innovative new initiative – the Partnership for Action Learning in Sustainability (PALS) – to assist local governments in tackling complex policy issues broadly related to economic, social, or environmental sustainability. The program is based on a successful and cost-effective national model. A county simply articulates its needs and University faculty and students from across campus pool their resources and thinking to analyze and address those needs. PALS has been piloted in the Cities of Frederick and College Park, and is about to be implemented in Howard County. Panelists will provide an overview of PALS, discuss how the program has worked so far in Maryland and elsewhere in the nation, and highlight the kinds of issues the program can help address.

Build It and They Will Come: Infrastructure Tools to Attract Private Investment

Learn how to meet local needs and create opportunities for economic growth by leveraging the Maryland Department of Housing and Community Development's Local Government Infrastructure Financing program and Neighborhood BusinessWorks small business loan program. From improved water treatment to infill development, from commercial rehabs to streetscape improvements and new construction, this session will provide information on the financing tools that can grow existing businesses and attract new investment. The session will highlight specific projects and discuss how county governments can use these programs to impact economic success within their local communities.

County Financial Management

The BRF – A Lifeboat for the Chesapeake?

County governments have had to bear the implementation and fiscal brunt of significant water quality mandates for nearly a decade, including the Chesapeake Bay Total Maximum Daily Load, new requirements for stormwater management, and the use of best available technology nitrogen removal (BAT) septic systems. Throughout this, the Bay Restoration Fund (BRF) has been one of the few sources of State financial assistance for upgrading both major wastewater treatment plants and BAT septic systems. As our water quality targets undergo a major review in 2017 and the BRF completes funding of the major plants, the time is right to also revisit the purpose of the BRF. Panelists will provide an overview and history of the BRF and discuss how the BRF can be revised to better meet county water quality needs for wastewater treatment plants, BAT septic systems, and stormwater management.

From Stone Tablets to eTablets – the New Public Information Act & Open Data Reality

Both technology and citizen expectations are changing the way governments store and handle information. In turn, this has created pressure to update and “modernize” the State's public information laws and policies. The Maryland General Assembly passed legislation during the 2015 Session that substantially changed Maryland's Public Information Act (PIA), including how counties must respond to data requests and the fees they can charge. Additionally, Maryland is at the forefront of a nationwide trend to open government data and make it available to the public in digital formats. While such changes have many benefits, they also create significant implementation and cost challenges for county governments. Panelists will discuss the recent changes to the PIA and provide an overview of the advantages and drawbacks of Maryland's open data efforts.

Body Cameras: Justice Through the Lens

Body cameras are an innovative technology that can be used as a tool in modern policing to increase relations between law enforcement and the communities they protect, while also serving as a means of maintaining accountability. Jurisdictions across the nation and the state are increasingly equipping their officers with cameras. However, as law enforcement agencies begin to adopt and deploy this emerging technology, much is still being learned. Attend this session to hear from local law enforcement officials about the benefits and limitations of body cameras - including legal and liability issues - and about updates on state action that may impact the future use of body cameras in Maryland.

Turf Wars – the Debate Continues

Catching the Wave: Change Management for Public Sector Leaders

However, the base thresholds for the tax are \$10,200 for self-only coverage and \$27,500 for all other coverage tiers - with higher thresholds available for certain participants - leading to a very broad application that might better be nicknamed "Chevrolet." Plan sponsors, including county governments, should take steps now to understand when their plan may hit the excise tax thresholds and how to minimize the tax's impact.

Today & Tomorrow – An Update from the Maryland Sustainable Growth Commission

Planning on Planning? You'll Need a Plan for That

While many people know that a county must develop a detailed comprehensive plan to guide development and zoning ordinances, not everyone is aware of the numerous other plans that a county must create (and sometimes get approved by the State) in order to meet various land use and environmental goals. Besides comprehensive plans, counties must develop and update various related plans, such as: water and sewer plans; forest conservation plans; land preservation, parks, and recreation plans; and growth tier designations for septic systems. Counties must also oversee various plans for individual developments, such as stormwater management plans and grading and sediment control plans. Panelists will discuss the components of the comprehensive plan and many of the other land use plans that counties must create, review, or enforce.

From the Front Lines: Tackling Opioid Misuse in Maryland

In response to the continued increase in opioid-related fatalities in Maryland, the Governor convened the Heroin and Opioid Emergency Task Force and Regional Summits across the state to hear directly from residents about the problems and potential solutions to the opioid epidemic. Additionally, the Department of Health and Mental Hygiene's Behavioral Health Administration (BHA) initiated the Opioid Misuse Prevention Program (OMPP) with the goals of reducing prescription opioid and heroin misuse and abuse, reducing opioid related overdoses, and reducing fatalities that occur as a result of opioid overdoses. To gather more community level data, BHA collaborated with the University of Maryland School of Pharmacy to develop and administer the Maryland Public Opinion Survey on Opioids. This session will provide an overview and preliminary reports of the State's community-based and data-driven efforts to overcome opioids.

The State Budget, and its County Effects – Where Do We Stand?

The State and its fiscal position has a major ripple effect on county budgets and our many shared policy priorities. Even as the economy shows signs of recovery, Maryland still faces challenges with revenues, competing desires for spending, and tax reductions.

Three high schools in Prince George's County have been awarded \$7 million as part of the federal government's Youth CareerConnect program. REGISTRATION

General Policies

- Registration DOES NOT include hotel reservations. Registrants must make their own hotel reservations. MACo provides a list of discounted hotel room rates for Summer Conference registrants.
